#### Hon. Warren Snowdon's MP visit to Torres Strait

The Minister Hon Warren Snowdon, Minister for Veteran's Affairs, Defence Science and Indigenous Affairs, will be visiting Thursday Island from Wednesday 6<sup>th</sup> April to Thursday 7<sup>th</sup> April 2011. As part of the Minister's visit, Department of Health and Ageing (DOHA) has proposed a Roundtable Meeting involving key stakeholders. The Torres Strait Regional Authority Chairperson has proposed that a joint agenda be developed between Torres Strait Regional Authority, Torres Shire Council, Torres Strait Island Regional Council and the Northern Peninsula Area Regional Council. Topics should be submitted through the TSRA's Governance and Leadership Program. TSRA apologizes for the short timeframe.

# Department Environment Resource Management (DERM) - Land Transfer Program

# \$1.4 billion Regional Development Australia Fund (RDAF)

Whilst \$350 million is already earmarked to rebuild regional Australia devastated by recent natural disasters, there is over \$1 billion available from the Regional Development Australia Fund (RDAF) to provide financial grants supporting the infrastructure needs and economic growth of Australia's regions. I have requested that the CEO and Directors identify the funding guidelines for the extension of the airport runway and the development of a new international terminal for the Horn Island airport. These proposed airport developments have solid economic and social opportunities for our region as well as both Cape York and our international northern neighbors — such as mining/tourism/educational and health research/security and emergency services. The proposed airport developments will link our regional communities across traditional and international boundaries.

# • Rebels Donga, Nawie Street Horn Island.

Bus driver currently living in the donga, which was approved as 'site office'. Rebels buses are parked either on the nature strip or on the neighbours vacant block and the bus driver is often seen refuelling the buses by drums of diesel and a siphoning hose. There is a childcare across the road and a medical centre three doors down, plus the residents directly either side - are there any risks to anyone in the close vicinity with this practice? What are Councils local laws about this sort of thing?

CEO advised that some weeks ago DPES wrote to Rebels on this issue and will follow up when he returns from leave.

#### • Nature Strip in Outie Street, Horn Island

Peita and Garth McGeachie who previously operated the Horn Island Motel has been looking after the nature strip outside their residences in Outie Street, Horn Island. They are doing a great job. I don't know if they have officially adopted the area through the Councils program, but I am requesting Council formally acknowledge the great work they are doing. Youth often use the area as a park or a meeting place, its just a real pity that they don't respect it.

CEO will write a letter to Peita & Garth McGeachie commending them on their efforts in maintaining the nature strip outside their property in Outie Street and along the rest of the street..

# Horn Island Foreshore Beautification Project

As mentioned at the recent Audit Meeting, I am keen to know how we can assist to speed things along to have this project begin? Michael Guise has offered his assistance with machinery (for free) to help with doing something. Greg Kirk from Ports Corp advised that he has copper logs/old power poles that can be used to build a sea wall. I have not approached Sea Swift, but I'm sure they can do something. What I'm thinking, is that in the short-term (until a formal agreement can be reached with PCQ Head Office) is that we just build the sea wall, extend the roof area of the existing waiting shed and remove the actual vacant toilet cubicles, keep the roads around the immediate area safe for pedestrians and traffic. In the long term, with ongoing negotiations and securing much needed funds, a proper public toilet needs to be built and an additional road to be cut in close against the Sea Swift fence line to allow the heavy traffic to use that road. This could be a good partnership with the business mentioned above, as well as the wider Horn Island community. I have been advised that this could be done as a Community Working Bee, to avoid any litigation issues.

Cr Bin Tahal will follow up with correspondence to the stakeholders from the Horn Island Residents & Ratepayers Association.

- Buses are often dropping off or picking up on the rise at Ratbag Ridge Horn Island. This has become a very unsafe practice, as there is no actual turn off lane to allow the traffic flow. What improvements can be done, within existing budget, to make this more safe for all road users?
  - Director Engineering Services will follow up this situation.
- Parking outside South Pacific Store Airport Road Horn Island can be a hazard when drivers insist on parking directly in front of the door or paranell to the premises. If guard rails could be located near the area, or an actual line marked parking done, this would not only make the entry more safe for all users, but it would also allow a more controlled area. Would this be looked at as part of the upcoming Roads and Drainage project on Horn Island? What specifically is planned for the project?
  - Director Engineering Services will investigate this area and report back in his next report.
- NSC Community Meeting took place on Saturday and a Committee has now been reestablished. There were some positive suggestions from the floor including: a quarterly community clean up of the complex, a suggestion for key pick up/drop off at the local Childcare, key bond to be increased, opening hours Monday, Wednesday and Friday from 6pm - 9pm etc. Minutes will be forwarded in due course, which will include all action items.
  - CEO will refer this report and pending minutes to DPES to follow up the necessary issues.
